We are pleased to inform you that your paper "Heterogeneity of Central Bankers and Inflationary Pressure" has been accepted for presentation in an academic session at the XX Annual Inflation Targeting Seminar of the Banco Central do Brasil, which will be held at the premises of our Rio de Janeiro branch, on May 23-25, 2018. Congratulations for this accomplishment.

We have received 154 high quality papers, which made the selection of 26 papers very difficult. This outcome makes us confident that this will be an intellectually stimulating and very productive event. At this point, in order to finalize the program of the Seminar and assure its high quality, we ask you to confirm as soon as possible – and no later than March 26, 2018 – whether you, or one of your co-authors, are actually intending to present the selected paper at the Seminar. If you are not the author who will present the paper, please forward this message to your co-author who would present the paper.

The logistical issues below can help you in your travel planning:

Flight Reservations: The Central Bank of Brazil would be pleased to purchase an economy airline ticket to Rio de Janeiro for one author per paper accepted for the Seminar. Please note that due to Brazilian Federal Government rules and requirements, we can only issue an airline ticket within one day before and one day after the seminar, and only to the city where the seminar will occur. We have to make the reservation here and buy the air tickets with our Brazilian travel agency. So, if you need any financial support for your travel ticket to Rio de Janeiro, please let us know.

Hotel Accommodations: The Central Bank of Brazil will make hotel reservations and cover accommodation costs from May 22 to 26 for one author of each paper accepted for the Seminar. Participants are responsible for all charges other than the daily room rate, and are expected to settle any additional expenses on departure. If you wish to arrive before or stay after the above mentioned dates, you should arrange for accommodations at your own expenses.

Visas/Travel: If you are a foreign participant, a visa may be necessary for entrance in Brazil. Please confirm with the appropriate Brazilian Embassy for the particulars. Each participant must arrange to obtain his or her own visa for entrance in Brazil.

The Central Bank of Brazil will arrange pickups from the airport to the Hotel upon your arrival in Rio de Janeiro and from the Hotel to the airport on your departure. There will also have a daily shuttle service between Hotel and the Central Bank building.

When we receive confirmation from you, our colleague Jane Sofia (seminar coordinator) will send you the Seminar Speakers Form that will provide the seminar organizers some details of your paper and your travel to Brazil.
